Aim: The aim of the course is to acquire knowledge about theoretical and methodological basics of planning behavioral disorders prevention in the community, developing a critical research attitude, as well as practicing the conceptualization and designing skills of behavioral disorders prevention programs.

Outcomes: Students' ability to plan behavioral disorders prevention based on the results of previous assessments and actual theoretical and research achievements, to independently implement activities of assessing the readiness, needs and potential of the community for prevention, as well as to master the skills of developing a model and action plan for the behavioral disorder prevention programs.

Content

Lectures: The process of prevention planning (concept, historical development, principles). Theoretical basics of prevention planning (community readiness concept for prevention, prevention planning models, developmental theories of behavioral disorders). Research basics of prevention planning (longitudinal studies of risk and protective factors, evaluation research). Practical basics of prevention planning (principles of effective programs, elements of program structure, steps in modeling program design).

Practical work: Practical models of prevention planning (characteristics, elements, phases, activities). Assessment of readiness, needs and potentials. Community readiness assessment instrument (elements, implementation, analysis and interpretation of data). Defining program structure (steps, procedures). Creation and presentation of program models (objectives, tasks, theoretical and research basics, theory of change). Creating an action plan for the program.
